# **Help Us Achieve Our Goal**

Too many of us are finding out how truly short life can be. Every day, there is a new, stunned and horrified person who learns that two who had become one have become half again. It is as if you are in the

crosswalk and the 70 mph Greyhound bus doesn't notice you until it hits you. Your heart explodes in a crush that

stops you instantly. You can't breathe it hurts so bad.
You are spared most of the questions: "do you know anyone who would want to harm someone that has never hurt another soul intentionally in her life?" Clearly cables and wires that had been connected to a missing television provide the officers the first clue. The body on the floor probably walked in as a burglar was walking out. He was walking out with property that didn't belong to him.

The previously non-violent burglar is about to become a very violent felon with your loved one. Of course the Police have to ask, "where were you at the Coroner's stated time of death?" Of course you know they checked it out. The Coroner? You know they have checked it out. Someone with good intentions will actually tell you to your face that the police actually have to rule the immediate family out before looking elsewhere. Of course you understand...well sort of...

Suddenly, there is an arrest and an arraignment is scheduled. The media wants to talk to you. They never had even noticed you existed before. Now, they have questions. One of them is asking you, "how did you feel finding the love of your life on the floor of your kitchen?" You wonder how hard it would be to garner sympathy from a jury of your peers for assaulting a reporter with insensitive questions.

To add insult to injury you get to watch perfect strangers debate with themselves as to whether or not they could or couldn't imagine how you feel! The entire world (apparently except for one) is sorry for your loss! You remember hearing in a funeral service that someone once said, "I haven't lost my bride. I would have never been so careless with something that precious to me!"

Numb, you wake up and get dressed. You grow a beard for the first time in your life. The morning before the memorial service the steel blade against your neck looked, well, easy. Somehow you find yourself in front of a massive door in front of courtroom number 605. A nice but firm bailiff with a clipboard asks you why you are there. You desperately want to say, "I have no idea?" The bailiff asks you who the defendant is in your case? Your mind goes blank...

Suddenly a nice person walks up. The person apparently recognizes your stunned face from media reports. The nice person tells you that they are a Victim's Advocate with the Justice Coalition. They ask you what appears to be the most intelligent and comforting question you have heard since the attack on your family. The Advocate asks you, "may I help you get through this?"

The advocate points on the clipboard held by the bailiff and points at one of the lines that says, "State of Florida vs. (defendant's name). The Advocate is telling you that if you have a cell phone with you that you need to turn it all of the way off. It cannot simply be on vibrate. Just then the Bailiff in a firm voice asks you, "do you have a cell phone with you? You have to turn it all the way off. If the judge hears it vibrating, you will be kicked out of the courtroom. You have no idea how long this will take. It is over as

# A Lesson in Morality

Nearly 150 people gathered in the parking lot of a Westside shopping plaza to honor 7-year-old Heidy Rivas Villanueva. Family, friends, and even strangers wore white T-shirts with the little girl's smiling face on them. Heidy's father sat leaning forward with his face buried in his hands. Her mother wept beside him. The opening prayers offered by Rev. Ronnie Cucuta were in Spanish, but the fervor and intensity in his voice was easily interpreted by everyone in attendance.

Å week earlier, Heidy was sitting in the back seat of her father's car with her younger sister, waiting for their mother to return from picking up groceries inside the El Tapatio store on 103rd Street. In an instant, gunfire erupted around them—13 shots in total. Bullets slammed into the side of their vehicle. When the shots stopped, Leonel Rivas whipped around to see if his children were okay. He found that his daughter had been

struck in the head by a stray bullet.

"When I was paying, my husband ran inside and screamed, 'They killed my little girl,'" Beatriz Villanueva, Heidy's mother, said. "When I went outside, she was already in his arms and he started running toward the hospital." Heidy died in her father's arms.

The shooting was a result of a

robbery under the pretense of a gun sale. 21-year-old Abrion Price and 17-year-old Trevonte Phoenix set up the "sale" on social media. A third man, 19-year-old Stanley Harris, served as the lookout for the buyer. When Harris saw that a robbery was happening, guns were

# Tampering with the Victim

In cases of child sexual assault, the young victim is often threatened by the perpetrator. Typically, the child is threatened that if they tell anyone about what happened, harm will come to them. Sometimes the perpetrator threatens to

hurt the child, and in other cases the perpetrator warns the child that if they report the incident to anyone, the child will be taken away from their family or will suffer other bad consequences. In the past, the perpetrators were not often charged with the separate crime of tampering with a witness. A recent decision by the appellate court for Northeast Florida may change that. In rendering their decision, the Court cleared up some confusion about the evidence necessary to sustain a conviction for tampering with a wit-

The defendant had been charged with the crimes of sexual battery and tampering with a victim. Florida law defines tampering with a witness or victim as the use of intimidation, physical force, threats, or misleading conduct with the intention to hinder, delay, or prevent communication about a crime to a law enforcement officer or judge. The defendant argued that the state had to prove that he directly inhibited the child's ability to contact law enforcement. The defendant argued that previous appellate decisions had developed a general rule that disabling the victim or witness's phones, by itself, was not enough. The State had to prove that the victim or witness was attempting to call law enforcement at the time the phones were broken. The defendant argued that this requirement applied to all charges for tampering with a victim or

The appellate court in this case declined to endorse or establish any such general rule. Instead, the appellate court clearly stated that the only general rule that did apply was that the State must prove the defendant knowingly took some type of action with the intent to hinder, delay, or prevent the victim from communicating information to law enforcement relating to the commission of the offense. The appellate court then applied the correct general rule to the facts of this case. At the defendant's trial, the State submitted evidence that the defendant told the victim "not to tell nobody or he'll come back and he'll hurt her." The court found that the State's evidence was legally sufficient to show that the defendant knowingly intimidated the child victim to prevent her from reporting the sexual battery to law enforcement. The court found that the State presented sufficient evidence to sustain a conviction for tampering with a victim. The defendant's convictions were affirmed.

The name of the case is Frazier v. State, and was decided by the First District Court of Appeal on June 28, 2018. This important decision should open the door for additional criminal charges in this all-to-common scenario in crimes committed against children.

drawn and the shooting began. The gun fight transitioned over from a nearby IHOP, to the shopping plaza where Heidy and her family were parked.

It's easy to say that Heidy was in the wrong place at the wrong time. It is true that she had the terrible misfortune of being caught in the crossfire at that exact moment. But living in Jacksonville is beginning to feel like being in the wrong place all of the time. Heidy was the fourth person under 18 killed this year.

Residents in Jacksonville expressed concern over the recent spate of violent crime. Following Heidy's shooting, in an anonymous letter to Mayor Curry and Sheriff Williams, one citizen wrote, "Jacksonville is a war zone and no one seems to care."

Mayor Curry, who's top priority is public safety, tweeted his disgust following the shooting. "My Lord. My God. This is heartbreaking. These are our children. I've spoken to the Sheriff. Our cops are in pursuit of these terrible people. Prayers for the family. Our law enforcement will bring the full force of the law

on those who committed this."

Some attribute the uptick in violent crime to a lack of police presence or a lack of investment in public safety. But whether or not that has any truth in it, that explanation camouflages a broader, more troubling problem. The degradation of morality—the loss of a common humanity and dignity. What has happened to a community's understanding of shared values? When did personal ethics take the place of a basic sense of right and wrong shared and understood by

In Heidy's case, the men involved fired deadly weapons in a public space with no regard for anyone or anything around them. Their moral code is so twisted that one of them

actually used the Villanueva's car as a shield as they continued to shoot over the top of their vehicle.

Four years ago Heidy Rivas Villanueva's parents left Honduras for America. They were seeking a brighter future—the opportunity to raise their family in a safer environment. In Honduras, where 60% of the population lives below the poverty line, widespread gang violence drives suffering and instability. It's commonplace for criminals to extort families into paying a "war tax" for their protection. If they can't afford to pay, they are often killed.

They came to our country, our state and city looking for a safer place to raise their family. Instead, they are sending their 7-year-old daughter back to Honduras in a coffin. I think it's time for Jacksonville to take a long, hard look at itself. We

need to reestablish what our shared values are. For all our differences, placing a greater value on life is something we can all agree on. We're all in this together.

Police Supervisor of the Month

Police Sergeant Brian Davis\*



Brian recently made a lateral move to work as a supervisor in the JŠO Narcotics Unit. Before he started in this undercover role he was a supervisor in the Burglary Unit. He is recognized for his leadership role that led to the successful conclusion of a recent operation.

Earlier this year, Brian and the members of the Burglary Unit identified a trend: an unknown suspect was

burglarizing grocery stores throughout Duval County including Publix, Winn-Dixie and Harvey's locations. Brian was tasked with coordinating with personnel at the headquarters of both Publix and Southeastern Grocers, as well as tracking the crimes and implementing an action plan. Brian studied the suspect's patterns and identified the stores that were most likely to be burglarized next. He used this information to help organize stakeouts in all six patrol zones.

After four days of stakeouts and no arrest in the case, Brian adjusted the plan to help save taxpayer dollars. The new plan involved a Burglary Supervisor watching live video feeds of the stores during the times identified from the suspect's previous crimes. This in turn cut down on the personnel hours being used in the field.

At around 3:00 am on March 5, Brian was monitoring the live feeds when he observed the suspect burglarizing a Harvey's location on University Boulevard. He notified the Zone 3 Officers in the area and they immediately responded to the store where they took the suspect into custody as he was exiting with the stolen goods. The investigation revealed that the suspect was indeed the same one that had burglarized the previous locations.

Due to Brian's actions and partnership with both Publix and Southeastern Grocers, the suspect was taken off of the streets and 11 burglary cases were cleared. Sheriff Mike Williams said, "I know I speak for everyone at Publix and Southeastern Grocers when I say GREAT WORK! Your actions are truly commendable. Thank you for leading by example. I am honored to present you with the July 2018 'Police Supervisor of the Month' award!"

#### Police Officers of the Month

Melissa Bujeda and Christian Hancock

Chris and Melissa are assigned to work in the Professional Standards Division and more specifically in the Public Relations and Information Unit. They were honored for their efforts and forward thinking that has helped increase JSO's communication with the citizens they serve. Additionally, their teamwork has led to a decrease in auto burglaries to vehicles in our city.

Sheriff Mike Williams said "three years ago when I became Sheriff, I pledged to focus on three things:

- Reducing violent crime
- Engaging the community
- And Using Resources Efficiently

Well it's no surprise that Chris and Melissa have helped with these three to-dos and they strive to make sure that JSO is transparent and accountable to the public each and every day. They do this by using tools such as JSO's social media accounts to get the word out about

crimes in our city and more importantly they have one-on-one dialogue with citizens.

What you may not know is that in addition to going on television and posting messages on JSO's social media channels these two process crime tips and fill public records requests. Basically this means they work all different hours of the day to make sure that the citizens of Jacksonville are informed on what is going on in our community."

The following numbers document their work product in just 2017:

- They processed more than 8,000 plus tips that came in from citizens;
- Sent out more than 650 news releases and media advisories;
- Responded to 20,000 private messages on Facebook Messenger;
- And participated in well over 150 ceremonies, events and media interviews.

Additionally, they personally filled more than 10,000 public records requests just last year! This number represents more than 20% of the total requests received by the entire agency. Their witty and interesting approach to posting on social media helped JSO earn Folio Weekly's "Best Local Facebook Page" recognition in 2017.

Lastly, in the first half of 2017, there was an upward trend in auto burglaries and firearm thefts from vehicles. Melissa went on a search for a way to use social media to help reduce these incidents and keep these

She discovered a program being used by another agency where citizens were reminded every night to lock their doors. Working with Chris, they launched the 9 P.M. Routine here in Jacksonville. Every night since mid-June of 2017, JSO social media followers have been treated to humorous memes or daunting statistics to help remind them to lock their car doors, remove weapons from their vehicles and secure them safely in their homes.

After one year of the 9 P.M. Routine reminders, JSO has seen a 17% reduction in auto burglaries to unlocked vehicles.

Chris and Melissa's immediate supervisor, Police Lieutenant Chris Brown said, "Many of our officers often times exceed expectations, but Chris and Melissa have done something in their positions that I have rarely seen—they have dedicated themselves to a lifestyle where they engage our community every single day of the year, through holidays, through hurricanes, and through many missed family events."

Sheriff Mike Williams said, "Chris and Melissa, thank you for your hard work around the clock to help get vital information out to our community. I am honored to present you each with the July 2018 'Police Officer of the Month' award."



#### Civilian Employee of the Month

Public Records Coordinator Jade Gibbs

come into the agency. She received the July 2018 "Civilian Employee of the Month" award for her overall approach to her job and more specifically for the way she handled a request that she was assigned in November last year.

Working in this unit requires a certain skillset which includes an eye for detail in making sure files are thoroughly reviewed for redactions prior to being released. This not only protects the agency and individuals involved, but also helps JSO comply with the law.

Another important trait is being a good communicator. This goes a long way in helping to understand what the requestor is asking for so that an estimate can be provided taking into consideration the many facets of what the individual is looking for and how long it will take to review and redact the materials.

Jade exhibited these skills and has proven herself in this role. In fact, in November of 2017 she was assigned a request for traffic camera footage for a specific date, time and location. Prior to the disbandment of the program, Jade worked with one of the Red Light Camera Liaison Officers to

Jade works behind the scenes in the JSO Public fulfill the request. This request was not that simple however. The footage had to be carefully reviewed to make sure that what was on the recording did not capture anything from an active investigation.

> Through Jade's review of the footage and in-depth search for police reports from that time period and location, she learned that the video contained an event that led to an individual being arrested for Driving Under the Influence. She also learned that the requestor just so happened to be this individual's attorney. Jade worked with the State Attorney's Office to find out the status of the case so she could proceed with filling the request.

> With the case pending prosecution, Jade was meticulous with her redactions and when the General Counsel's Office received a call from the requestor questioning the redactions, she was able to fully explain the actions that she took were in full compliance of the law.

> Jade's immediate supervisor, Freda McDowell said, "she always goes the extra mile to ensure that she processes her requests correctly and in a timely manner. Jade is always willing to help her fellow employees and goes above and beyond her job duties."

> Sheriff Mike Williams said, "Jade, thank you for your dedication to your job and to this agency. Keep up the great work! I am honored to present you with the 'July 2018 Civilian Employee of the Month' award."

In addition to spouses who are victims of domestic violence, their children are often affected by life-long psychological problems. These three books provide information and advice for the children of the victims domestic violence. Lundy Bancroft is a therapist who founded the program that focuses on counseling men who are domestic abusers. However, in his book, When Dad Hurts Mom: Helping Children Heal the Wounds of Witnessing Abuse, Bancroft focuses on providing advice to mothers to help their children overcome the trauma of witnessing their own abuse by a domestic partner. He explains how abusers often manipulate their children and describes the resulting psychological impact on them. Expressly addressed to abused mothers, this book provides valuable advice and a concrete plan of action to mothers on how to protect their children and help them recover from the trauma of witnessing abuse by their father.

#### Childhood Experiences of Domestic Violence By Caroline McGee


A British psychologist, Caroline McGee's book, Childhood Experiences of Domestic Violence, contains detailed first-hand accounts by 48 mothers and 54 children about their experiences with domestic abuse, as well as their experiences with social service professionals who are charged with providing support services. This approach dramatically reinforces the need for all involvedmothers, physicians, and social workers—to understand the full effect of domestic violence on the children who witness it. It emphasizes the need for communications with victims and their children in order to allow early identification of affected children. McGee strongly advocates a multidisciplinary approach to providing support services specifi-




cally for children affected by domestic violence. She does not shrink from criticizing organizations and government agencies for not providing competent services. To her credit, she includes many alarming accounts by victims of such shoddy care.

#### Children Who See Too Much: Lessons from the Child Witness to Violence Project By Betsy McAllister Groves

Betsy McAllister Groves



is a pediatrician and founder of an organization based in Boston whose purpose is to identify and provide professional help to young children who are victims of domestic violence. Her book, Children Who See Too Much: Lessons from the Child Witness to Violence *Project,* emphasizes the hidden nature of the pain that children experience as a result of witnessing domestic violence. She provides many examples of the dormant effects of domestic abuse and how such effects are not adequately identified and addressed by pediatricians, psychologists and other professionals. She



provides lessons from her own medical practice to guide professionals in identifying children who have witnessed domestic abuse. As a result of McAllister's efforts, the U.S. Department of Health and Human Services created the Safe and Bright Futures Initiative to encourage communities to establish services for children who have been exposed to domestic violence. For the general reader, this book provides valuable awareness of the problem of the effects of domestic violence on children so that those affected can seek professional help. quickly as it began. You are wondering what in the world just happened. The Advocate, paid for by contributions made by friends of the victims and/or the Coalition, asks if you have ever had any experience with the legal system?

No...no one has ever murdered anyone you were actually living for before. You think, wait a minute. No! You have never murdered anyone before either. The Advocate chuckles even as they continue to ask great questions. "Are you aware that there are funds available for counseling, burial costs, and replacement income?" The Advocate offers to help you fill out the paperwork. You discover that you are going to be coming to the courthouse every two weeks to a month for the next year. Possibly even two years!

It suddenly occurs to you that you haven't seen anyone that even remotely resembles Jack McCoy, who will be nailing the animal who thrust you into this scenario. You are angry as you are seeking something that is referred to as justice and/or closure. The Advocate interrupts your thoughts and asks you if anyone from the State Attorney's office has contacted you. The Advocate offers to reach out to the State Attorney's office to find out who will be handling the case.

You thank the Advocate for all of their help. You are told the one thing that has given you any sense of hope since you lost your loved one. "We will be with you as long as this case is active." You realize that you have made a friend. You ask, "until the verdict is pronounced?" The Advocate smiles and says, "until after the appeals!"

# 6,378 Previously Untested Sexual Assault Kits Processed

Attorney General Bondi announced the latest progress report outlining the testing of thousands of previously unprocessed sexual assault kits. According to the latest Sexual Assault Kit Progress Report released by the Florida Department of Law Enforcement, 6,378 backlogged kits have been tested so far. State and private labs are testing the kits as part of an ongoing effort to process thousands of previously untested kits in Florida.

The state legislature approved initial funding to eliminate the backlog during Florida's 2016 Legislative Session. During the session, Attorney General Bondi worked with law enforce-

ment, prosecutors, survivors and state lawmakers to secure \$2.3 million for testing, and additional funding to raise the wages of lab analysts to reduce turnover, purchase new forensic testing equipment and upgrade existing lab equipment.

Attorney General Bondi also supported legislation to help expedite the testing of all DNA evidence, including sexual assault kits. Now, Florida law requires all newly collected kits to be processed within 120 days of receipt. According to the latest report, FDLE has a 99.9 percent compliance rate with an average turnaround time of 85 days for newly received kits.
